NARRATIVE

ON 4/30/16 I SGT SHARP WAS TRAVELING SOUTH ON CR 245 WHEN I OBSERVED A BLACK ECLIPSE TRAVELING WEST ON HWY 118. I OBSERVED THIS VEHICLE ATTEMPT TO MAKE A RIGHT TURN ONT CR 245 TOWARDS ME. THIS VEHICLE TURNED TOO SOON ONTO SCR 245 CAUSING THE VEHICLES FRONT PASSENGER TIRE GO WELL INTO THE DITCH. THE DRIVER THEN ACCELERATED AND WAS ABLE TO EXIT THE DITCH ON ITS OWN. I THEN TURNED AROUND ON CR 245 AND HEADED NORTH TOWARDS THIS VEHICLE (ALSO NB). THIS VEHICLE WAS NOW TRAVELING AT A HIGH RATE OF SPEED. I OBSERVED THIS VEHICLE SLIDE INTO THE DRIVEWAY OF THE FIRST RESIDENCE TO THE WEST AND THE FRONT PASSENGER DOOR QUICKLY OPEN. I THEN OBSERVED A WHITE MALE EXIT THE PASSENGER SEAT AND FLEE SOUTH.

SGT BOURLAND GAVE CHASE TO THE FLEEING SUBJECT AND I STAYED WITH THE DRIVER. THE DRIVER WAS IDENTIFIED AS MIKE MULLINS. I ASKED MR MULLINS WHO FLED AND HE RESPONDED "I DON'T KNOW, I JUST PICKED HIM UP". I ASKED MR MULLINS WHO'S HOUSE WE WERE AT AND HE COULDNT GIVE ME AN ANSWER. SGT BOURLAND CHASED THE SUBJECT THE RESIDENCE INTO THE FIELD AND BACK ONTO CR 245. SGT BOURLAND WAS ABLE TO CATCH AND TAKE THE SUBJECT INTO CUSTODY ABOUT A QUARTER MILE SOUTH OF THE RESIDENCE WHERE THIS INCIDENT STARTED FROM ([REDACTED]). I THEN RETRIEVED MULLINS ID AND WENT TO ASSIST SGT BOURLAND. THE OFFENDER MICHAEL SPARKS WAS EXTREMELY MUDDY FALLING SEVERAL TIMES AND APPEARED TO BE EXHAUSTED. MR SPARKS ADVISED THAT HE RAN BECAUSE "COPS SHOOT FOLKS ALL THE TIME". MR SPARKS, SGT BOURLAND AND MYSELF ARRIVED BACK AT [REDACTED] WHERE MR MULLINS AND HIS VEHICLE STILL WERE. MR SPARKS WAS PLACED INTO THE BACK OF DEP COBURN'S VEHICLE FOR THE TIME BEING. ACCORDING TO DEP COBURN, MR SPARKS SPONTANEOUSLY STATED "THAT STUFF WASNT MINE, THAT GUY THREW A BAG IN MY LAP AND TOLD ME TO RUN....I THREW IT OUT IN THE YARD BEHIND THE HOUSE". AT THIS POINT NOTHING WAS YET LOCATED. MR SPARKS FOOTPRINTS WERE EASILY TRACKED DUE TO THE HEAVY RAIN RECEIVED JUST HOURS EARLIER. WITHIN A FEW MINUTES A LARGE BAGGIE OF METH (6.7 GRAMS) WAS LOCATED IN THE MUDDY FIELD ALONG THE EXACT PATH MR SPARKS RAN. BESIDE THE LARGE BAG OF METH WAS A SMALL BAG OF METH (.25 GRAM) AND A DRY \$10 BILL. THE BILL WAS INCLUDED WITH THE EVIDENCE TO SHOW THAT IT WAS RECENTLY DISCARDED DUE TO IT BEING COMPLETELY DRY.

THE HOME OWNER [REDACTED] THEN ARRIVED ON SCENE. [REDACTED] ADVISED THAT NO ONE WAS AT HOME DURING THIS INCIDENT AND NEITHER SUBJECT HAD ANY RIGHT TO BE ON HIS PROPERTY. [REDACTED] ADVISED THAT HE DID NOT KNOW MR MULLINS AND DIDNT KNOW MR SPARKS PERSONALLY.

I THEN SPOKE WITH MR MULLINS. HE ADVISED THAT HE PULLED INTO THE RESIDENCE BECAUSE HE WAS "NERVOUS". MR MULLINS THEN GAVE WRITTEN CONSENT TO SEARCH HIS VEHICLE. I LOCATED A RED NIKE CASE BEHIND THE DRIVER SEAT. THE CASE WAS UNZIPPED AND CONTAINED SEVERAL PLASTIC BAGGIES COMMONLY USED TO PACKAGE NARCOTICS. MR MULLINS ADVISED THAT THE RED NIKE BAG WAS HIS "LUNCH BOX". NOTHING ELSE WAS LOCATED. I THEN LAID THE RED NIKE BAG ON THE GROUND BY THE VEHICLE AND RAN K9 KIRA AROUND THE EXTERIOR OF THE VEHICLE. K9 KIRA GAVE A VERY STRONG ALERT ON THE RED NIKE BAG. K9 KIRA ALSO ALERTED ON THE DRIVER DOOR. MR SPARKS THEN GOT MY ATTENTION AND AGAIN INSISTED THAT HE HAD "NOTHING TO DO WITH IT". MR SPARKS AGREED TO WRITE OUT A STATEMENT SAYING THE METH BELONGED TO MR MULLINS. [REDACTED]

[REDACTED] WRECKER SERVICE SOON ARRIVED ON SCENE AND TOOK POSSESSION OF THE VEHICLE. MR SPARKS WAS CHARGED WITH POCS METH AND FELONY FLEEING. MR MULLINS WAS WITH POCS METH WITH AN OSCEOLA COURT DATE OF 5/2/16. NOTHING FURTHER.
